0.1  $\mu$ g of Human Her2, His tagged protein per well




Figure 1. ELISA plate pre-coated by 1  $\mu$ g/mL (100  $\mu$ L/well) Human Her2, His tagged protein (PME100095) can bind Anti-Her2 (trastuzumab biosimilar) mAb (BME100048) in a linear range of 3.2-400 ng/ml.

0.1  $\mu$ g of Human Her2, hFc tag protein per well




Figure 2. ELISA plate pre-coated by 1  $\mu$ g/mL (100  $\mu$ L/well) Human Her2 Protein, hFc Tag (PME100665) can bind Anti-Her2 (trastuzumab biosimilar) mAb (BME100048) in a linear range of 3.81-1730.10 ng/mL. In order to specifically detect BME100048, mouse anti-human Fab-specific antibody was used as detection antibody.






Figure 3. Flow cytometry analysis with 15  $\mu$ g/mL Anti-Her2 (trastuzumab biosimilar) mAb (BME100048) on HEK293 cells transfected with Human Her2 protein (Blue histogram) or HEK293 transfected with irrelevant protein (Red histogram).




Figure 4. Flow cytometry analysis of antigen binding of anti-human Her2 mAb(BME100048).

(A) BME100048 does not bind to Jurkat cells that do not express Her2.

(B) A clear peak shift of BME100048 was seen compared to the control when incubated with Her2-expressing MCF-7 cells, indicating strong binding of BME100048 to Her2. Antibodies were incubated at 2  $\mu$ g/mL.
